Limitless Summer Break Program is a great way for kids to safely channel their energy during this new norm. Parents have the comfort of knowing that their children can interact with other children in a safe and stimulating environment. What we are doing to prioritize health and safety of your child at camp.

- **Group Size:** Group sizes will be limited according to the CDC and Broward County Guidelines. Groups will remain together throughout the day and separated from other groups.
- **Daily Screening:** All children will be temperature-checked and parents will be asked a set of questions about their recent health each time they drop off their child.
- **Masks/Face Coverings:** Staff is required to wear facial covering throughout the day. Children are required to wear facial covering when entering the facility and when physical distancing is difficult.
- **Floor markings and signage:** Safe distances will be marked to help keep children appropriately spaced. Reminders for handwashing and social distancing, and safe sneezing will be posted throughout the facility.
- **Hygiene:** Scheduled handwashing breaks will be built into each group’s schedule. In addition to that, more hand sanitizer stations throughout the building for use.
- **Activities:** Activities will be modified to limit physical contact. Equipment will be cleaned between uses and/or sufficient supplies will be provided for all children to enjoy. We intend to keep camp fun and your child can expect to enjoy many of the same favorite activities they have enjoyed in the past.
- **Field Trips:** Following guidance from the CDC, we will NOT offer field trips this summer. We will be incorporating special programming instead.
- **Cleaning:** Staff will be regularly cleaning to disinfect our facility throughout the day & perform a deep-clean every night after closing.

FAQs

***What are the dates and time for summer programming?**

The 2020 Summer Program runs June 15th – August 18th. Extended program is also available August 17th – 18th. Summer hours are from 8:00am – 3:00pm and 8:00am – 6:00pm for extended care.

***How will drop off/pickup be conducted?**

Drop off - Children will be dropped off outside of the facility and a staff member will sign them in (guardian will not be permitted to enter the facility). Children will be required to sanitize their hands and a temperature check prior to entering the facility.

Pickup – Guardians are not permitted into the facility. A staff member will greet you outside. Once it is confirmed that you are on the pickup list, the child will be signed out by the guardian and the counselor will bring the child to the pickup area.

***What will be taking place during summer programming?**

Although programming this year will look different without field trips, we still want to keep the fun our camp is known for. Our staff is planning several activities such as spirit week, arts and crafts, music, dance, Mad Science, STEAM, basic gymnastics, cooking, and extreme games to keep children engaged.

*** Should my child bring lunch? Change of clothes?**

Yes. Children should bring a lunch and 2 snacks (morning and afternoon). **Do not pack items containing nut products (peanuts, soy, etc.) as these are allergens to some of our campers and potentially life-threatening.** Children may bring an extra set of clothes (labeled with the child's name) in the drawstring backpack provided.

***Can my child bring electronics?**

Electronics are permitted to be used only during designated times. Please be advised that there is a high risk of damage or loss. **We are not responsible** for personal items children bring and highly discourage them.

***What steps are you taking to ensure my child is staying safe?**

Limitless Martial Arts will be following the CDC guidelines:

- Staff will be required to wear face coverings.
- High touch surfaces such as door handles, water fountains, etc. will be sanitized multiple times through the day.
- Children will remain with the same group and same staff throughout the day. Intermingling between groups will be restricted.
- Both staff and children will be required to wash/sanitize hands frequently.
- Each group will have a designated room. Upon arrival, Children will place their belongings in their designated area.
- There will be no communal eating. Children will eat lunch and snack in their designated area. Children will maintain social distancing while eating meals. Children will not be able to share food.
- Any child complaining of illness or showing symptoms will be removed from their group immediately and be placed in a designated area and the guardian will be called to pick up the child. As recommended by the CDC, if your child has a fever, they cannot return until they are 72 hours fever free without the aid of medicine.
